4Q23 SPIFF Terms & Conditions

- Under this program, selling agents who are directly contracted in good standing with Lingo + Bullseye are eligible to participate,
- The promotion begins on **October 1, 2023, and ends on December 31, 2023**, (the "Promotion Period"). The promotion is only valid on new contracts entered into during the Promotion Period and replace all other SPIFFs and/or customer promotions for the products listed. Moves, changes, upgrades, downgrades, and reconfigurations are not eligible.
- Regulatory rates and fees are not eligible.
